V. Status Report on the Land Use Diagram

Planning Staff presented a report on the changes to the Land Use Diagram since the last GPAC meeting, including revisions by the Gilroy Planning Commission and Gilroy City Council. Planning Staff also presented changes to individual parcels since the last GPAC meeting and the inclusion of the Urban Growth Boundary. GPAC members and community members asked clarifying questions about the changes.

After questions, the GPAC voted to consider approval of the Land Use Diagram for inclusion in the General Plan. GPAC member Glines voted nay, GPAC members Sanford and Pace abstained, and the remainder of the GPAC voted aye.

VI. Review of the Land use Element of the General Plan Policy Text

General Plan Consultant Dave Amos gave a brief presentation on the General Plan structure and contents, as well as more detailed information about policies and implementation programs. GPAC members discussed the policies in the Land Use Element Goal Section LU 1 and the GPAC took no formal action.
